## County plans Telegraph Creek protection

Telegraph Creek is exposed to additional sediment and nutrient runoff during the wet season, which degrades the quality of the water.

Telegraph Creek flows to the Caloosahatchee, which in turn empties into the Gulf of Mexico. The creek is a popular run for kayakers and canoeists, who frequently launch next to the bridge on North River Road.

Lee County is planning to spend \$107,900 on a study to prepare for a project that will change how land along the creek drains into the water.

A vote to award the study contract to Boylan Environmental Consultants was on the Jan. 6 agenda for the County Commission.

Problems to be addressed include breaches in berms and ditches that break up agricultural lands along the creek.

The county wants to create a situation where water will remain on the land long enough for the sediments and nutrients to settle out before they get to the creek. The county is applying to the South Florida Water Management District for grants to pay for the construction work that will be required.

## Lee County an achiever in statewide recycling

Lee County is years ahead of schedule when it comes to meeting its recycling goals, according to a county press release.

Florida's Department of Environmental Protection says communities should score 75 percent on their recycling rating by 2020. Lee County hit 74 percent in 2012, although it dropped to 70 percent in 2013.

Lee County's focus will be to increase recycling in 2015 at multi-family, business and construction-demolition projects.



## River Hall proposal still has life within it

Lee County planning staff recommends approval of GreenPointe Communities' latest proposal to change land use and add more homes to the River Hall community.

A public hearing is set for Jan. 14 at 9 a.m. before the Lee County Hearing Examiner in Fort Myers.

The case is being watch because opponents say approving the proposal goes against the Caloosahatchee Shores development plan. Approving it would undermine community plans throughout the county, opponents say.

The staff report backs GreenPointe's proposal to increase the number of residential units by 696 for a total of 2,695. The developer previously attempted to increase the number by 1,000 units.

The achieve its goal the developer wants to change zoning on some of the 553 acres involved from rural to an outlying urban category.

Previously the developer asked for 850 units in a proposal that was forwarded by the Lee County Commission to the state for comments. So far the state agencies commenting on that version have not found any conflicts with state goals and objectives or uses of state property.

The latest proposal is smaller in part because residents now control the River Hall Community Development District board.

The board voted to withdraw any district property involved in the proposal from consideration for rezoning.

## Open enrollment, chickens on The Alva School agenda

**Open enrollment** — the time when parents can request their students be assigned to a specific school next year —, begins Jan. 20 and ends March 27.

Parents of students moving up to middle or high school and of children entering school must complete the paperwork. They can do it online on the district's web site. All applications will be processed after the enrollment period ends.

Science teacher Cherie Sukovich's students also are creating a wetlands to help them study how stormwater is cleaned up. Students will take water samples to measure how well the wetlands filter rain water.

Students also are taking water samples from the Caloosahatchee River at the Franklin Lock and the Alva boat ramp as part of their Human Impact on Earth Unit of study.
